

# **Rabbit Bonding Agreement**

This agreement outlines the terms and conditions for a rabbit being temporarily housed and bonded with another rabbit at Lucky Bunny and Friends Rescue ("Rescue"). The Owner acknowledges the responsibilities associated with the rabbit's stay at the Rescue and agrees to the terms stated below.

# Terms of Bonding and Stay

1. Vaccinations Requirement

The Owner agrees that their rabbit is fully vaccinated against Myxomatosis, RVHD-1, and RVHD-2. Proof of current vaccinations must be provided before the bonding process can begin. The Rescue reserves the right to refuse a rabbit that is not fully vaccinated.

#### 2. Health and Insurance

The Rescue highly recommends that the Owner ensures the rabbit is covered by pet insurance prior to drop-off. This insurance is essential to cover any potential veterinary costs that may arise during the stay, as the Rescue will not be responsible for such expenses.

## 3. Veterinary Costs

The Rescue will not be held responsible for any veterinary costs incurred during the rabbit's stay, including but not limited to illness, injury, or emergency care. If veterinary attention is required, the Owner will be contacted immediately and will be responsible for all associated costs. The Owner must provide the contact information for their preferred veterinary clinic and authorize treatment if necessary:

# **Owner Responsibilities**

1. Supplies Provided by Owner

The Owner is responsible for providing all necessary supplies for their rabbit during its stay, including but not limited to:

Food (pellets, fresh greens, hay, etc.)

Any prescribed medications and instructions for administering them

Bedding or other items that may comfort the rabbit

2. Pick-Up Date

The Owner agrees to collect their rabbit on the agreed date of: \_\_\_\_\_\_. If the rabbit is not collected by this date, boarding fees will apply as outlined below.

#### **Rescue Responsibilities**

#### 1. Bonding Supervision

The Rescue will oversee and facilitate all bonding sessions between the Owner's rabbit and the bonding partner rabbit. These sessions will be conducted in a neutral and safe environment, with the safety of both rabbits prioritized.

#### 2. Boarding Care

While in the care of the Rescue, the rabbit will receive appropriate housing, fresh water, food, and regular exercise. Daily supervised bonding sessions will be conducted to assess and encourage compatibility between the rabbits.

## **Boarding Fees & Rehoming Terms**

#### 1. Boarding Charges

If the Owner fails to collect their rabbit by the agreed pick-up date, a boarding fee of £10 per day will be charged. The Owner agrees to this fee and understands that these charges will continue until the rabbit is collected.

2. Failure to Collect

Should the Owner fail to collect their rabbit within 7 days of the agreed collection date, without prior notice and agreement from the Rescue, the Rescue reserves the right to reclaim the rabbit. The Rescue may then proceed to rehome the rabbit as per its standard rehoming process. In this event, the Owner forfeits any claim to the rabbit.

#### **Liability Waiver**

The Owner acknowledges that bonding can sometimes lead to minor scuffles between rabbits, and while the Rescue will do everything in its power to prevent harm, it cannot be held liable for any injuries, illnesses, or medical conditions that may occur during the bonding process. The Owner agrees to indemnify and hold harmless the Rescue from any claims, losses, or liabilities arising from the rabbit's stay at the Rescue.
